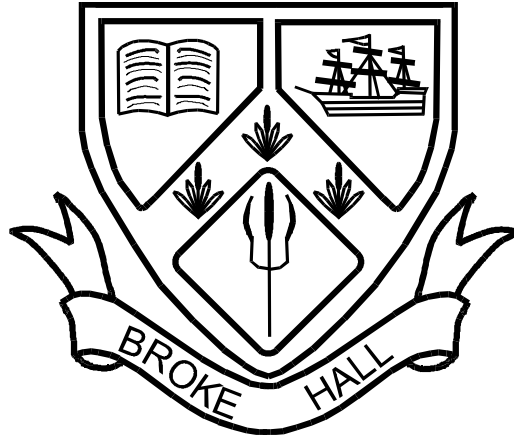

## 1 Introduction

The curriculum comprises all learning and other experiences that are organised to promote learning, personal growth, and development. It includes not only the formal requirements of the National Curriculum, but also the range of extra-curricular activities organised by the school to enrich the experience of the children. At Broke Hall Primary School, we ensure that our curriculum is ambitious, broad, balanced, and relevant and that it meets the needs of all children. The taught curriculum is comprised of The National Curriculum and the wider curriculum. We ensure that the children have a range of learning experiences that challenge, stimulate, and promote thinking and learning, as well as spiritual, moral, cultural, and physical development.

Our curriculum also includes the 'hidden curriculum', i.e., what the children learn from the way they are treated and expected to behave. We aim to teach children how to grow into positive, responsible people who can work and co-operate with others while developing knowledge and skills, so that they achieve their true potential.

In addition, we harness opportunities in all aspects of our curriculum, both taught and hidden, to ensure that the children understand the importance of respect and leave school better prepared for life in modern Britain.

Our curriculum meets all statutory requirements.

## 2 Values

Our school curriculum is underpinned by our school values. The curriculum is how the school achieves its objective of educating children in the knowledge, skills and understanding that they need to lead fulfilling lives. Our values are **Inclusion, Resilience, Independence, Knowledge & Understanding and Curiosity.**

- We value the way in which all children are unique. Therefore, our curriculum promotes inclusion through respect for the views of each individual child, as well as for people of all cultures, gender identities, ethnicities, socio-economic groups, and abilities. We value the spiritual and moral development of each person, as well as their intellectual and physical growth.
- We value the importance of each person in our community. We organise our curriculum so that there is co-operation and understanding between all members of our community. We actively promote the fundamental British values of democracy, the rule of law, individual liberty, mutual respect, and tolerance of those with different faiths and beliefs to ensure children become valuable, fully rounded members of society who treat others with respect and tolerance, regardless of background.
- We value the rights enjoyed by each person in our society and actively promote the UNICEF Convention on the Rights of a Child. We respect each child in our school for who they are. We treat them with fairness and honesty. We aim to enable each person to be successful and we provide equal opportunities for all children in our school.
- We value our environment. Our curriculum teaches respect for our world, including how we should care for it for future generations as well as our own.

## 3 Aims and objectives.

The aims of our school curriculum are:

- to enable all children to learn and develop their skills to the best of their ability.
- to promote a positive attitude towards learning, so that children enjoy coming to school and acquire a solid basis for lifelong learning.

- to promote high standards in reading, writing, maths and the foundation subjects
- to enable children to be creative and to develop their own thinking.
- to teach children about their developing world, including how their environment and society have changed over time.
- to help children to value and understand Britain's cultural heritage and enable them to be positive and inclusive British citizens.
- to fulfil all the requirements of the National Curriculum and the Locally Agreed Syllabus for Religious Education and help children to develop an awareness of their own spiritual development.
- to promote physical and mental development and an awareness of the importance of a healthy lifestyle.
- to teach children the importance of, and to participate in, the arts and related cultural experiences.
- to help children understand the importance of truth and fairness, and to develop a moral sensibility and a sense of right and wrong, so that they grow up committed to equality of opportunity for all.
- to enable children to have respect for themselves and to be able to live and work co-operatively with others.

### 4 Organisation and planning

The curriculum is planned effectively using research-backed evidence, providing continuity and progression. It promotes an enjoyment of learning and a commitment to growth and achievement.

Through the provision of rich and varied activities, we aim to:

- encourage the best possible progress and the highest attainment for all pupils.
- enable pupils to make connections across different areas of learning.
- help pupils to think creatively and solve problems.
- develop pupils' capacity to learn and work independently and collaboratively.
- enable pupils to respond positively to opportunities, challenge, and responsibility.
- enable pupils to acquire and develop a broad range of knowledge, skills and understanding.

Our curriculum is planned in three phases. We agree a long-term plan overview for each subject indicates the units which are to be taught in each term and to which groups of children. We review our overview annually:

- The **Long-Term Plan** incorporates the requirements of the statutory curriculum, ensuring that the curriculum is progressive whilst also incorporating enough flexibility to respond to (or harness) events of national or global significance to enhance our curriculum.
- **Medium Term Plans** give clear guidance on the learning objectives and teaching strategies to be used when teaching a topic. Teachers make use of the school values when planning engaging activities that will enthuse children. Visitors and/or educational visits are planned, wherever possible, to incorporate authentic experiences that will bring learning to life. For more information, please refer to individual subject policies. Assessment opportunities are included in these plans.
- **Short-term plans** are the plans written and used by teachers on a weekly or daily basis. These are used to set out the learning objectives for each session, to identify which resources are required and clarify those activities to be used in each lesson. They will also include opportunities for retrieval of prior learning from which the children can build their knowledge.

### 6 Roles and Responsibilities

The Headteacher has the responsibility for the leadership of the curriculum and delegates responsibility to key staff:

- the Assistant Headteacher co-ordinates the work of the subject leaders and ensures that the curriculum has progression and appropriate coverage.
- Subject Leaders are responsible for medium term plans and for liaising with class teachers over the content and delivery of the units of work. They evaluate and monitor standards in their subject (see below).
- Class Teachers ensure that the curriculum is taught and that the aims are achieved for their class. They plan collaboratively to ensure parity across the year group.
- the progress of each pupil is tracked to ensure that appropriate challenge, support, and intervention are provided.
- Governors monitor the success of the curriculum at committee level and at whole Governing Body meetings through the Headteacher's report and 'Monitoring and Curriculum Committee' meetings.

### 7 The role of the subject leader

The role of the subject leader is to:

- provide a strategic lead and direction for the subject including maintenance of the subject policy.
- support and offer advice to colleagues on issues related to the subject.
- monitor planning and pupil progress in that subject area.
- provide efficient resource management for the subject.

It is the role of each subject leader to keep up to date with developments in their subject, at both National and local level. They review the way the subject is taught in the school and plan for improvement. This development planning links to whole-school objectives. Each subject leader reviews the curriculum coverage charts for their subject, ensures that there is full coverage of the National Curriculum, and that progression is planned into schemes of work. The subject leader also maintains a portfolio of children's work, which they use to show the achievements of children at each key stage and to give examples of expectations of attainment.

### 8 Monitoring and review

Our Governing Body's 'Monitoring and Curriculum Committee' is responsible for monitoring the way in which the school curriculum is implemented. The Curriculum Leader is responsible for maintaining the curriculum overview. The Headteacher, School Leadership Team, Subject Leaders

and Phase Leaders monitor lesson planning, ensuring that all classes are taught the full requirements of the National Curriculum and that all lessons have appropriate learning objectives. Subject leaders also monitor the way their subject is taught, learned, and assessed throughout the school. They examine long-term and medium-term planning and ensure that appropriate teaching strategies are used. Subject leaders also have responsibility for monitoring the way in which resources are stored and managed.
